

REGISTRATION CHECKLIST:

STEP 1: Fill out the registration paperwork FRONT AND BACK (4 sides/pages) and pay fees

- **Write check to BHRC** for the per swimmer team fee which includes one swim cap:

STEP 2: **Write check to DAWN TODD** for \$50/swimmer + any additional shirt fees

\$50 covers 1 swimmer t shirt, end of season party (food, trophy/awards, lifeguard wages), swimmer of the week awards, photo sitting/online image access fee and office supplies such as toner, paper, ribbon labels, etc.

STEP 3: Register your swimmers on [OUR WEBSITE](https://bhrcswim.swimtopia.com/) <https://bhrcswim.swimtopia.com/> and explore the site. The REGISTRATION button is at the top left of the homepage. There is a JSSC fee of \$15 per swimmer that you must pay for your swimmer to participate on team and swim in meets- this fee covers liability for your swimmer's participation and helps defray some of the cost incurred by purchasing the new equipment we will use this summer and for years to come.

STEP 4: Visit Swim and Tri via our team portal online [HERE](https://www.SwimAndTri.com/TeamView_BrookHighlandRacquetClub.aspx)

AT BHRC on the registration date, you may try on suits, **YOU MUST ORDER YOUR OWN SUITS AND ANY EQUIPMENT NEEDED.** The suit is the same as 2025, so if yours still fits you are good to go! I do not order suits or equipment for the swimmers. This is also a great time to stock up on swim essentials (goggles, practice suits, etc).

NEW SWIMMERS may need to ask me which package to get - NEW young swimmers (4-5YO) would probably be ok with a beginner pack (just a board) - anyone who will likely move up needs intermediate (board and fins). Older swimmers need advanced packs (board, fins, paddles, buoy).

RETURNING SWIMMERS please double check your fin sizes!

STEP 5: Download the SWIMTOPIA app onto your phone so you are ready to follow along at the meets. Basic functionality is FREE. If you'd like to see more things (like timelines, current score "live" results) there is an option to purchase monthly for \$5.99 (you'd need TWO MONTHS-don't forget to cancel) or annual for \$14.99. UPGRADING IS OPTIONAL - it's fine to run with the free version.

STEP 6: Ask questions as needed - there are no stupid questions! Since we are learning new meet and team management software this summer we will be working through the process together. We may have a few bumps but it will be great in the long term so bear with us this summer!
