  - a. Lengthy discussion by all members regarding concerns related to appropriate staffing of volunteers for meets; tri meets offered as a possible rescheduling fix to alleviate volunteer stressors
  - b. Board recognized *relaxed* expectations in past seasons in response to COVID-19 concerns; board agreed to return to PRE-PANDEMIC recommendations for the number of timers and officials
  - c. GSAVAL executive board STRONGLY recommends adhering to SCORING BYLAWS Article VII C-G. for each meet and every effort should be made by both/all teams to assure proper staffing
    - i. Each visiting team is expected is to a minimum provide one timer per lane\*, one stroke official, and one turn official
    - ii. Each host team is expected to provide two timers per lane\*, a referee, a starter, a head timer, one stroke official, and one turn official
    - iii. Manual/ Stopwatch Timing reminders; 2 timers per lane; the mean time is the official time. 3 timers per lane; if two times agree, that is the official time, if the three times differ, the median time is the official time
    - iv. \*varies from our 5 to 6 lane member pools
