Course: Eight lane, outdoor, 25-yard pool with non-turbulent lane lines, Colorado timing system, continuous warm up / warm down available throughout meet.

The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with articles 105.1.7 and 107.2.1.

Eligibility: Any swimmer with a valid 2020 USMS registration or a valid travel permit from another country is eligible. Each swimmer must submit a copy of their 2020 USMS registration card or travel permit with their entry.

Rules:

1. 2020 USMS rules apply.
2. All events are timed final.
3. Swimmers are limited to a total of 8 individual events for the entire meet and no more than 5 per day not including relays.
4. Age on March 27, 2020 determines the age group of the swimmer for the entire meet.

5. All events, except the 1650 free & 1000 free, will be pre-seeded. Only the 30 swimmers (mixed) registered for the 1650 free will get to swim. Only the first 30 swimmers (mixed) registered for the 1000 free will get to swim.
6. The 1650 will be seeded fastest to slowest based on entry times. All other events will be seeded slowest to fastest.
7. Positive check-in is required for the 1650 free and 1000 free events. Check in for the 1650 free and 1000 free will close 30 minutes prior to the session each day.

Entries and fees: Entries will close on Monday March 23, 2020 at 11:59p.m. Late entries will not be accepted. There will be no deck entries.

There is a flat \$50 fee for the meet IF YOU ENTER ONLINE. Online entry is the ONLY way to enter this meet.
