## 2022 GRPA District 5 Swim Meet

**Facility:** The competition pool is a 50 meter by 25 yd. pool which will be set-up in short course, 25 yd. configuration with a 10 lane competition course (running 8 lanes for this meet) and 10 lane warm-up/cool down pool. The water depth is 7ft. throughout the whole course. We will use a Daktronics timing system. No Food or drink will be allowed on the pool deck. Spectators will not be allowed on to the pool deck at any time.

The outdoor play pool will open at 10:00am and you may purchase admission to this pool, it will be open to the public and will only allow admittance to 200 people. Teams may set up tents in our open spaces near the parking lot area and beside the building.

**Parking:** There are approximately 350 parking spaces at CCAC. There will be a swimmer drop-off area in front of CCAC during the event. Security will be on site to patrol parking lots. Illegally parked cars will be towed at the owner's expense.

**Directions:** Take Interstate 575 to exit 11 Sixes Rd. If driving from the north you will make a right on Sixes Rd., and if coming from the south you will make a left on Sixes Rd. First left is WellStar Way. Drive all the way to the back.

**Concessions:** Concession stand will be available during the meet with one window on the inside of the facility, and a second window on the outdoor play pool deck. A hospitality area will be provided for all officials, coaches, and volunteers, located in Wet Classroom A on the competition pool deck.

**Rules:** Current USA Swimming rules will govern the conduct of this meet unless overridden by GRPA rules. Any swimmer who enters the meet but "no shows" the day of the meet, the agency will be fined \$10. The fine is payable to GRPA District 5. **Swimmers will be responsible for swimming in their assigned heats and lanes.** The meet referee has discretion to determine the need to do dive-over starts. The FINA rule will be in effect.

**Eligibility:** Open to all swimmers 7 years of age to 18 years of age by June 1st, 2022 that are residents of a city or county in the District 5 area that is not hosting its own qualifying meet.

Entry Limit: Each swimmer is limited to a maximum of three individual events and two relays.

**Entry Format:** Submit entries in standard data format (SDIF) or Hy-Tek (preferred), or on a standard meet entry form. Entries must include each swimmer's first and last name, age and seed time for each event entered. **Swimmers entered in the meet who are only competing as members of relay teams must be entered with all other participants for the purpose of verifying entries.** Their names should be submitted on the hard copy as relay only swimmers. A printed copy of all entries, fees, and a completed and signed liability release form from each team must accompany the entries.

**Entry Deadline:** All entries must be received at the address below by 10:00 am, June 21, 2022. Email entries may be made to Dan Ruehle, <a href="mailto:dan@smyrnasharks.org">dan@smyrnasharks.org</a>, provided that the hard copy, fees, and liability release form are received by the entry deadline. A confirmation email will be sent to all the teams. The order of events will be available in Hy-Tek format at <a href="https://www.smyrnasharks.org/district">https://www.smyrnasharks.org/district</a>. Late entries will not be accepted.

**Entry Meeting**: Roster Check in will be Tuesday, June 21, 2022 at 10:00 am at the City Of Smyrna Community Center, 200 Village Green Circle, Smyrna, GA 30080, with Jacob Groat and Chris Lash. Entries must be received by the start of this meeting. Please make sure that your entries meet the requirements for submission.

Seeding: All events will be pre-seeded in a circle seeded format

Format: 8 lanes will be used for the meet course

**Disabled swimmers:** Coaches for teams that have disabled swimmers competing must notify the meet referee at the coaches meeting. Disabled swimmers will compete as long as they meet the qualifying requirements.

Schedule: Warm-ups will begin at 1:00pm and will be determined by team. Meet will start at 2:00pm

Scoring: No scores will be kept

Awards: Medals 1st-3rd, ribbons 4th-8<sup>th</sup> in all individual events and relays Any awards not picked up at the conclusion of the meet will be shipped at the request of the team COD. Please make every effort to pick up your team awards at the end of the meet to avoid incurring shipping charges.

Coaches: Coaches will be required to sign in at the front desk at the Cherokee County Aquatic Center. Each team will need to submit with their entries a list of coaches who will attend the meet with copy of their required coaches' certification as dictated in the GRPA State Athletic manual. (1 coach per 25 swimmers with a max of 4 coaches will be permitted on the pool deck) COACHES WILL BE GIVEN AND REQUIRED TO DISPLAY THEIR SWIMMING BADGE WHILE ON THE POOL DECK AND IN HOSPITALITY. At least one coach from each team must attend any coaches' meetings. Each team will receive a packet at the meet with badges and heat sheets.

**Coaches Meeting:** A mandatory coaches' meeting will be held at 1:30pm on June 25<sup>th</sup>, 2022. At least one coach from each team is required to attend any coaches' meeting. Subsequent meetings will be arranged if needed. Coaches arriving late should check in with the Clerk of Course upon arrival.

**Warm-ups:** USA and Georgia swimming warm-up procedures and rules will be posted and must be followed.

All teams will be required to furnish at least one coach with current GRPA swimming certification to supervise each warm-up.

**Liability Release:** Georgia Swimming Inc., USA Swimming Inc., GRPA, and Cherokee County Board of commissioners, shall be free from any liabilities or claims for damages arising by reason of injury to anyone during the conduct of the meet.

**On-site amenities:** The following amenities will be on site during the meet: locker rooms, concession stand, , Free WIFI, Outdoor Play pool (for a fee).
