**Purpose:** The purpose of the annual Anne Arundel County Invitational Swimming Championships is to provide an opportunity for swimming competition among the county's summer swim teams. **All teams must submit a signed release form for each athlete.**

**Sponsor:** **Spy Swimming** (www.spyswimteam.org)

**Location:** **Severna Park Community Center**, 623 Baltimore Annapolis Blvd, Severna Park, MD 21146.

**Schedule:** **Warm-Up Times are approximate and are subject to change. Warm-up schedule will be posted after July 5th.**

**July 13: 11 & Over Boys and Girls**

Warm up: 4:30PM

Start: 5:30 PM

**July 14: 10 & Under Boys and Girls**

Warm Up: 4:30PM

**Eligibility:** This meet is open to all **Anne Arundel County** residents 18 years-of-age and under, who are bona fide members of a summer league swim team. [i.e. Not the coach. Not the lifeguard. Just the swimmers!] Please note however, that swimmers who are not associated with, or representing, a summer team may swim as an "unattached swimmer." Questions concerning eligibility should be referred to the Meet Director prior to July 5 , 2022.

**Waiver:** Consent and general liability release waiver of claims will be in a google form. Please send the link to your families. Click [HERE](#) for the google form.

**Entries:** A swimmer's age for this meet will be his/her **age as of June 1, 2022.**

Each swimmer may enter a total of **three (3) individual and two (2) relay events** (1 free relay and 1 medley relay). Swimmers **MUST** swim in their age group for individual events. Swimmers **MAY** swim up in age group for the relay events, but only 1 free relay and 1 medley relay.

***No “NT” time submission will be accepted. All entries must have a time.***

Each swim team may **enter as many relay teams as they wish. Only 1 relay per team may score in each event. Relays may be limited.**

Entry Fees: \$ 7.00 Per Individual Event \$28.00 Per Relay Event

All entries for individual events and relays must be listed on an official entry form. Entries must be in **yard times OR meter times** (we will convert to yard times for seeding.) However, teams must be consistent for all of its swimmers--either all yard times, or all meter times. Coaches should indicate courses used for seed times, but all will be converted to yards. [**Coaches Note:** Some local pools are neither 25 yard nor 25 meters. **Coaches are responsible for considering the length of their own pool when converting to yards or meters for the entry forms.**]

Deck seeds will be accepted as open water allows (extra heats will not be added).  
Cost of deck seed: \$10.00 for Individual Events/ \$30 for Relay Events

All fees and entries must be received no later than 12:00 PM, Friday, July 1, 2022.

## **Awards:**

**Medals:** Medals will be awarded in all *individual and relay events* for first (1st) through third (3rd) place for each age groups.

**Ribbons:** Ribbons will be awarded in all *individual and relay events* for 4th through 6th places for each age group.

Heat winner prizes will be awarded to all individual heat winners.

**Trophies:** High point awards will be presented to the top scoring boy and girl swimmers from the following groups (8& Under, 9-10, 11-12, 13-14, 15-18) for individual events, excluding relays.

**Plaques:** Team awards will be presented to the top three (3) teams (combining scores for all age groups), regardless of category, at the end of the meet.

**Rules:** This meet will be conducted according to the 2022 USA Swimming rules. All events will be swum as Timed Finals.

**Scoring:** Top 10 places will receive points for the team. Points will be scored through ten (10) places as follows:
