The following items were discussed at the board meeting and agreed unambiguously by all the members.

1. Board reviewed and approved the draft event calendar for 24/25 and will issue to parents
2. The Board agreed to announce swimmer's try-out date of Sunday, September 8th
3. The Board shall announce new group times starting Sunday 18th of August including land training times.
4. The Board agreed to send the sign-up for Friday Technical Correction Day from 18th August to end September (max 5 hours per coach per Friday as per their request).

11. The Board agreed to remind parents on the code of conduct as agreed with recreation.
12. The Board agreed to improve minutes of meetings documentation
13. The Board approved the purchase of new Dry-Land Equipment as per coach request.
14. The Board agreed to purchase a new underwater camera

The Board agreed that returning swimmers have the rights to renew full membership at 1000 SAR fee with registration allowing access to training, meets any time and participate in Technical Correction Day. The 200 SAR fee is also available but without participation in Technical Correction Days and swim meets.
16. The Board agreed to give the coaches 75% of the fees from the non-DYSL lessons for all their hard work during summer.
17. The Board agreed to find a large swim team for a competitive invitational meet.
18. The Board agreed to launch the merchandise website and order 3 sets of all items (S, M, L) as a tester order. Once received the website will be open to DYSL for two weeks in September.
